Subject: Declaration of Conformity regarding Hazardous Substances in Article

Dear Customer,

Thank you for your enquiry.

We hereby confirm that our company works in accordance with REACH regulation 1907/2006/EC in the currently valid version. MOMA NANOTECH srl is a nanotechnology treatments company and therefore a "downstream user" of application substances and mixtures in terms of REACH 1907/2006/EC.

Our products are not subject of registration or information the European Chemical Agency (ECHA) according REACH, article 7, paragraph 1 and 2 since our products do not contain substances and mixtures intended to be set free under normal and reasonably foreseeable conditions of use. To fulfill our obligations within the supply chain and to ensure product and operational safety, we are in regular contact with sub-suppliers.

According to present knowledge we confirm for our articles including packaging:

- ❖ Compliance with legal requirements of regulation REACH 1907/2006/EC in the currently valid version and that the articles do not contain any SVHC substances with a concentration of $> 0,1$ % w/w (weight by weight) or listed by ECHA List of Candidates (updated on January 15, 2018).
- ❖ Compliance with legal requirements of directive 2011/65/EG (ROHS II) on the "restriction of the use of certain hazardous substances in electrical and electronic equipment" in the currently valid version and that the articles do not contain heavy metals like lead, mercury, hexavalent chromium $> 0,1$ % w/w or cadmium $> 0,01$ % w/w as well as polybrominated biphenyls (PBB) or polybrominated diphenyl ethers (PBDE) with a concentration of $> 0,1$ % w/w in homogeneous materials.
- ❖ Compliance with legal requirements of directive 2000/53/EC (ELV) in the currently valid version and that the articles do not contain heavy metals like lead, mercury, hexavalent chromium $> 0,1$ % w/w or cadmium $> 0,01$ % w/w if the articles are not covered under exemptions listed in Annex II.
- ❖ Compliance with requirements of GADSL (Global Automotive Declarable Substance List) and VDA 232-101 (Revision Feb. 2015) regarding "prohibited substances and mandatory declaration in the automotive industry".
- ❖ Compliance with requirements of directive 94/62/EC in the currently valid version and that the packaging material do not contain any heavy metals like lead, mercury, hexavalent chromium or cadmium > 100 ppm.
- ❖ Compliance with requirements of directive 1005/2009/EC in the currently valid version and that the articles do not contain substances that deplete the ozone layer or increase the greenhouse effect.

We will inform you immediately when we receive new information from our suppliers due to updates of material safety data sheets (MSDS), the ECHA List of Candidates, the composition of mixtures or due to employment of new operating material and thus products or packaging includes hazardous substances according to the above mentioned regulations and that thereby the threshold value is exceeded in our product.
